

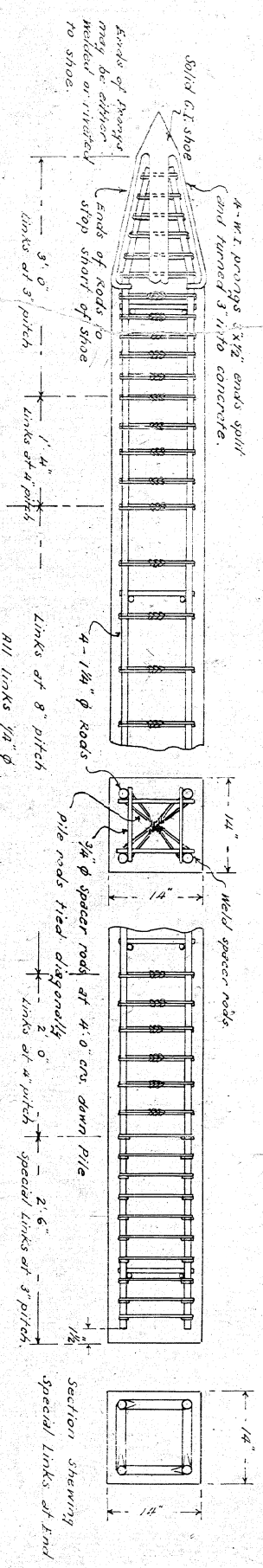

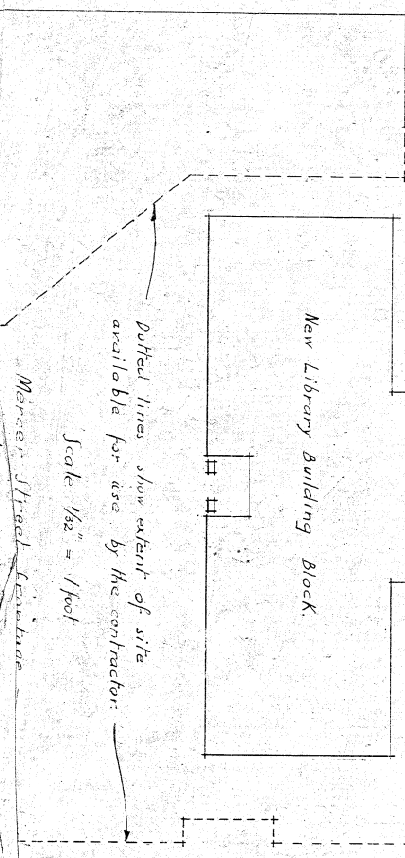
PART BASEMENT PLAN

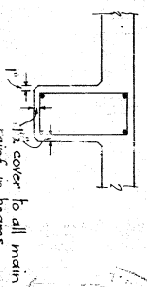

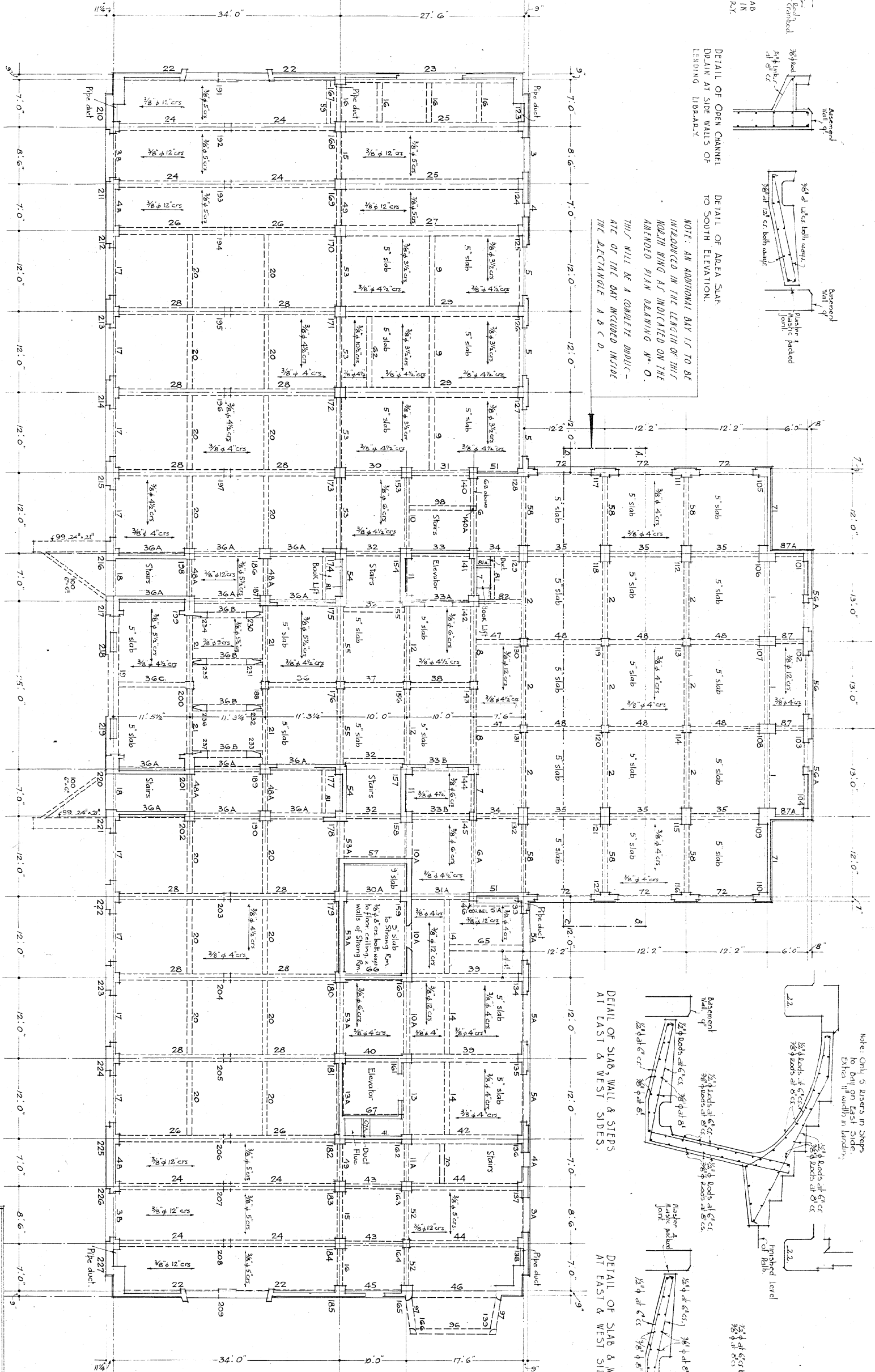


DETAIL OF OPEN CHANNEL DRAIN AT SIDE WALLS OF READING LIBRARY.

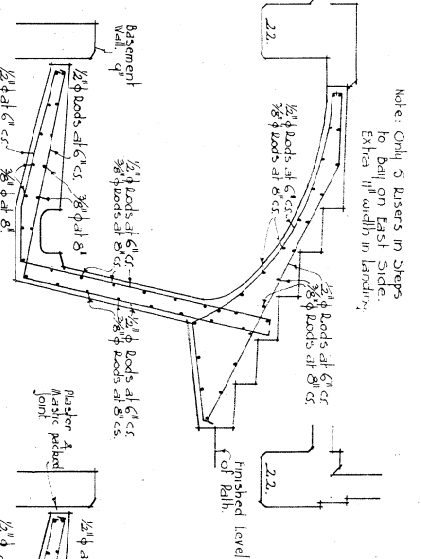

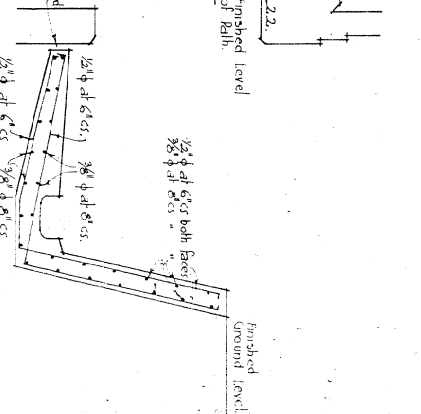

RODS IN COLUMN HAUNCHES:

FOR GROUND FLOOR CASE: All rods are to be taken through vertically to floor above, and short extra rods placed in haunch. These extra rods to be hooked at top & lapped 24 diams to vertical rods of bottom.

FOR 1st FLOOR CASE: The vertical rods on haunch side, except the corner rods, are to be anchored out and run to line of haunch, with hooked ends at top. The corner rods continue vertically up into buttress with short extra rods lapped to them & placed in haunch.
